- Last three (3) years Financial Statements and Annual Reports including Balance Sheet, Profit and Loss and Cash Flow Statement (preferably audited);
- Name of the contact person responsible for receiving the qualification package and other information and documentation.

Mandatory requirements for ref. **EOI_AZE_B1_B15_06_B18_B28_B31_43_2024 - Provision of Sea Transportation Services by Means AHTS (Anchor Handling Tug Support) Vessels:**

- The interested Company must be the Owner of the Vessel or the DOC holder (**ISM Manager**) in a **joint venture** with the owner of the vessel;
- The interested Company must hold a DOC (**ISM** Document of Conformity) valid for five (5) years and issued by an **IACS** Classification Society, which allows the interested Company to operate this category of vessel.
